Unfortunately, owing to the large volume of submissions we receive, we cannot provide you with an explanation, or return any materials you may have sent us should your idea be rejected. However, if we are interested in your idea, we will contact you regarding further action.

In the interest of both Griffin Technology and you, the Inventor, we strongly encourage you to seek patent protection on your idea before submitting it to us. If you are unsure how to go about this, you may find the American Bar Association publications "Submitting An Idea" and "Submitting An Idea To A Manufacturer" helpful. Before submitting an idea to us, you must first read and sign our Submission Agreement Form. Because of the complex legal issues surrounding idea submission (such as patent rights and confidentiality arrangements), we require that this form be completed, to protect your interests as well as our own. An unaltered signed copy of our Submission Agreement Form must accompany all submitted ideas; otherwise, the idea will not be considered for review.
